Meeting called to order at 6:10 pm

MINUTES

Motion was made to accept the last minutes by Ruth, seconded by Ed. All were in favor.

Committee Reports

- 1. Correspondence: Ruth reported there were two calls from ARL thanking us for support. Ed said several notes were received thanking us for the newsletter.
- 2. Treasurer's Report: Ruth just got a 10-month CD that will get \$500 in interest. We have \$1645 for the Buddy Scholarship this year. We have \$26,900 in total assets at the end of 2022, compared to \$24,015 for the end of 2021. We reviewed the budget. Budget decisions reported below.
- 3. Education: We were supposed to have a guest speaker, Toni Eaton from Sunny Paws Rescue, but she did not attend.
- 4. Lost Dog: Tracey reported that it was a fairly quiet period. Tony will need help putting out signs since he is having knee surgery.
- 5. Lower Cape Animal Shelter: Bev and Kathy Herrick have been in touch so that Kathy can cover for Bev while she is on medical leave.
- 6. Membership: Ed said some people did not get membership cards due to a glitch. All is set now, Cindy helped to fix it. We are at 138 members currently. Usually at 104 this time of year. Ed will send out another blast. We discussed whether we should give our member lists to our vendors. It changes a lot, so it's hard to keep up. We did not make a decision. Tony had trouble printing his membership card, and others have reported the same. Ed is sending a new file to the server which should help.
- 7. PR: Ed had nothing new to report.
- 8. Vendor Relations: We need to let our members know who our vendors are. We should put an article in the newsletter publicizing our vendors. Animal Hospital of Orleans (AHO) has been great. AHO is hiring two people if anyone knows any candidates. Tony is arranging a date to go in for Ed to take some pictures. Tony will clarify the services that are discounted at Nauset Canine Club.
- 9. Website: Ed reported it is running well.
- 10. Promotion: We are low on some merchandise; we should discuss what we want in the store. Katrina Boucher might want to help us with online store. Next month we should discuss what is our philosophy around merchandise: do we want to make money, or just promote ourselves?

Old Business

1. Tracey wants to follow up on plans for pond testing.

New Business

1. John told us that the dog first aid class was great. We should do it again. We don't know if the person who won the class at the Annual Meeting, Mary Traynor, actually attended. Ellen will check with her. (Subsequent to the meeting, Ellen found out that Mary did not know the date and did not attend. We will contact her directly if another one is scheduled to make sure she knows about it). We heard that the room at the Chapel in the Pines was too cold during the class. We need to discuss with them if it is held there again.

Event Planning for 2023

- 1. St. Patrick's Day Parade: we have been invited to march in the parade on March 11 in Yarmouth. We are going to decline, since we had such a low turnout for Windmill Weekend parade, and this one is quite a bit longer and not in Eastham.
- 2. Tracey will manage the Coexisting with Coyotes presentation/workshop.
- 3. Cindy will work on Rabies Clinic. (She also reported that Officer Keough is leaving as Eastham's ACO. No known replacement yet.)
- 4. Bow Wow Bash: Beverly ran this last year. We will see if she can do it again.
- 5. Hands on the Arts: Tony will follow up.
- 6. Windmill Weekend: this will be Karie and Cindy again.
- 7. Annual Meeting: too soon to plan.
- 8. Turnip Festival: Not sure what the format will be this year. Need to find out before we decide what to do, if anything.
- 9. Home Show: Ed said that Jim Russo from Chamber of Commerce asked him if we want to do the Home Show. It is \$500 to attend. We decided not to do it.
