Rules Changes at Wiley Park Update

EDOA has steadfastly maintained that dogs being allowed off leash is a recreational activity of great value to many citizens and needs to be continued. We

have been squeezed off beaches in the Summer, squeezed off Dyer Prince / Rock Harbor to limited access (on leash) by abutters complaints. Enough.

It seems that consensus means that dogs owners activities are the rights

that get denied and restricted. It seems that every perceived issue must be solved by some compromise that further limits dog owners. Enough.

EDOA so far has taken the position that issues that the Conservation Committee has with recreational use of Wiley Park can be solved by measures short of banning or limiting the off-leash option.

I walked the park areas in question with three Open Space Committee members last week. I left with the impression that these were reasonable people with great concern for the environment. We differed on the matter of certain changes to rules concerning dogs and agreed on the need for mitigation measures, many temporary.

The EDOA Board believes that an amenable, cooperative, educational approach will be effective. This would benefit both groups since our support and ed-

ucational reach can bring cooperation rather than attempting to dictate compliance and then trying to enforce it.

After reviewing recent Open Space and Cons Com

meeting video it is apparent that some members are receiving reports of issues laced with hyperbole. There is a posture of conflict by some members, while others clearly want consensus.

There are ConsCom public comment sessions that should be scheduled in the next couple of months. By then the Cons Com will have become organized and set in their position. It is in our best interest to be organized in ours.

The first step is to reflect on the reasons you like Wiley Park when walking with your dog. How you enjoy the shaded trails, water access, and nature of the area. Consider the positive interactions with dog /dog, dog / people, and people / people that enrich your experiences. Aggression and exaggeration are not productive for this discussion. Accentuate the positive.

Don't let more rules and limits become another faux solution to problems which can be mitigated in other ways.

Repair Approved by Conservation Committee Completed

Last week Keith Johnson, Conservation Agent, and I set off with rakes and shovel to repair damage in Wiley

Park. Seems that some dogs had been allowed to dig into ground along the trail near the bench closest to the bridge. The reair took about 10 minutes of our hour long meeting. We agreed that the dogs' behavior was inappropriate at best and illegal at worst. It resulted in damage that has been pointed out by Cons Com as evidence that dogs should be restricted to a leash. That is an unfortunate reflection on the dozens of visitors to Wiley with their dogs. The real damage was to

ourselves. And it was such a small thing. 10 minutes was all it took for Keith to declare the repair completed. The holes paled in comparison to the machine tracks recently made while doing storm cleanup by DPW. Still, the digging dogs should never have been allowed to do that and the cleanup equipment was necessary work. Please keep picking up, staying on the trails, and respecting others using the park.
