Wiley Park Rules What's Next

The dog owning community turned out for to defend the traditional uses of Wiley Park as regards potential changes being considered by the Open Space Committee and the Conservation Commission. About 170 signatories of our petition were delivered. Dozens of speakers and writers added their suggestions and opinions. Most defended the activity of allowing dogs off-leash as is the Town By-Law, "under immediate voice control."

Many also suggested ways to address the conservation concerns of the committees. Suggested were requiring dogs be leashed in the parking lots, beaches, trail entrances, and picnic areas. Education was a constant refrain including improved signage, trail demarcation, respect for reclamation areas, and consistent enforcement of clear rules of behavior.

In the spirit of the park as a shared recreational area, issues of some dogs treating the trails as a dog park were conveyed. Dog owners can, should and generally do respect other users on the trails. However, work needs to be done to make that behavior consistent for the enjoyment of all users.

EDOA has long offered to assist at creating a program to encourage the appropriate shared use of the park including dogs off leash.
